Principle Activities

The Club is a not for profit organisation, run by volunteers. Its principle activities are that of a BHS registered Riding Club, operating from its own base, which includes a small livery yard. The membership consists of children and adults from the area.

Report:

Current Club Status: Having held an extraordinary general meeting of its members, we created an incorporated by guarantee organisation during 2019 with the sole purpose to transfer the assets and liabilities of the unincorporated Club into the incorporated one. Due to some delays with completing the transfer and being able to set up a new bank account in the Limited club name, we do still remain reporting as the unincorporated organisation with the Limited Club filing dormant accounts. We are currently making inquiries if it is possible to complete the transfer of assets without the new bank account as due to Covid-19 the banks do not accept applications for new business accounts.

Therefore, the following pages show the financial statements for the year to 31.12.2020 of the unincorporated Club. We have included the year to 2018 as a point of reference from the last AGM.

Covid-19 – Unfortunately, the pandemic at the beginning of 2020 heavily impacted the Club's start, with our AGM being cancelled in March as a national lockdown began. While club activities were stopped the Livery yard continued to operate, with the dry spring we were able offer 24 hr turnout utilising the show field, this helped the livery members to manage the care of their animals while staying safe. We also used this opportunity to carry out some grassland management of the normally grazed fields. Once restrictions allowed, and after safety reviews we were able to set up a course of show jumps and the dressage arena to offer schooling sessions. These sessions proved popular, so extra days were arranged. However, with the lockdown stopping most activities, we did receive a grant from the Welsh Government via the Vale of Glamorgan Council of £10,000 relating to the farms rateable value.

All-Weather Arena – while the planned start of the main build of the arena was held up in 2019 due to some planning issues, it was hoped to start as soon as the weather allowed in 2020. Unfortunately, this was delayed further due to Covid-19. Further disappointment followed as we tried for Sport Wales (Sportlot) funding and after some very favourable responses, received the notification in July that we were not accepted for a grant. However, while later than planned, we were able to proceed with the build but were not expecting to complete the full size. After more ground levelling, some 760 tons of stone was delivered, 200m of fencing was erected, two levels of membrane were topped off by 580 tons of Cardigan silica sand... and we have almost completed our dream 60 x 40m all-weather arena. The final top surface has yet to be finished, thanks to Covid-19 impacting supply. We are still hopeful this will be completed by end of January.

During the year we also applied for a couple of other funding opportunities via Ford Motor Co, the Army Sports fund, and for a smaller grant from Sports Wales this time for a machine to enable maintenance of the arena – unfortunately none have been forthcoming, but we will continue to try!

Livery Yard – the yard is currently full with a couple of people on a waiting list. During April we did increase the charges following the increased charge for the rent of the farm. While we had machines on site for the arena we took the opportunity of adding a stone track to the turnout fields to help with turning out during very wet winters as previously this would involve leading horses across the car park field, which in turn damaged the field. We did unfortunately lose our long-term grazing-only livery from the bottom fields and have only had a temporary one since. So we do still have space for up to 4 horses (5 ponies), grazing only.

Looking forward: As we join everyone looking forward to being able to return to some sort of normality, the situation as we write is not looking good for an early start to activities. However, once we are able to, and with the benefit of the arena, we hope that while Club shows may not be immediately possible, we should be able to start regular training or course hire sessions once Government restrictions allow. In view of the constantly changing time, we will be using Facebook and the website for updates until the newsletter can be brought back, once planning can be more long term! If any members do not have access to our Facebook group or the website, please let us know so other arrangements for contact can be made.

Financial Statements Notes:

The main impacts to Club finances during 2020, as already mentioned above, were loss of Club activities due to Covid-19 and the build costs of the All-Weather Arena

The build cost was kept to a minimum using local contractors and buying supplies from various sources which did delay the build but enabled us to complete the full 60x40 arena to sand level (so far). There are still some bills to pay which are showing as creditors. However, the top surface, which we expect to be around £4,500, is not included in the figures. Total cost of the arena to date is £47,321 which has been capitalised as a fixed asset.

During the year we did receive that Government Covid grant of £10,000. We have also offered some local businesses the opportunity of displaying advertising banners on our arena fence for 2 years. Sponsorship received so far for this is £1,650 and our grateful thanks goes to Camso UK Limited, Horse-Sense, Llantwit Major self-storage, CP Motors, Health Conscious, The Chocolate Box and Arthur John & Co.

Financial Notes continued:

Statements: In view of the requirement to file our financial statements at Companies House going forward, we have re-structed the Income and Expenditure account onto one page (previously Farm and Club were separated). However, we have continued with the separate Club detail sheet.

Depreciation on Fixed Assets: The Club currently hold £21,520 worth of assets that are fully written down - this covers the show jumps, trailers, dressage and games equipment etc. Depreciation on All Weather Arena will be calculated over 9 years, which is the remaining length of our lease, starting in 2021.
